You stated/asked the following:

Ferguson's shipyard was nationalised in 2019 and is recruiting more apprentices.

1. How many workers are currently engaged in completing the Glen Sannox and its sister ship currently known as Hull 802.
2. How many of the workforce are resident and time served from the Inverclyde region and how many are foreign workers on contract with the Scottish government.

Response to your request

Please find our response to your request for information:

1. All directly and indirectly employed members of the workforce are currently engaged in completing the Glen Sannox and its sister ship currently known as Hull 802. As at 1st June 2021, this is 470 workers.
2. Of this number, 360 members of the workforce are directly employed individuals who possess a contract of employment with Ferguson Marine (Port Glasgow) Limited. Of this 360, 290 are resident within the Inverclyde area. Please note that we do not hold records as to which employees are time served within the Inverclyde area.

The remaining 110 workers are indirectly employed and sourced through a third party supplier. Please note that we do not hold records of where they are resident and time served.

None of our workforce (directly and indirectly employed) are foreign workers on contract with the Scottish Government.
